



## Disclosure Statement

**Psychologist:** Gary Seeman, Ph.D.

**Office Fees:** Payment is expected at the time of service. Charges for therapy are based on the allowable rate from the insurance carrier and vary greatly. If you have a deductible to meet or co-insurance, please ask for an insurance benefit check to determine your financial responsibility. Otherwise, you may be charged based on the highest allowable rate and potentially incur a credit. I prefer keeping your balance owing at zero to save administrative costs. Cash pay rates are negotiated with Dr. Seeman at the first appointment or prior. Session length is usually from 45 – 60 minutes and can be extended on a pro-rated basis with prior agreement or due to urgent necessity. Extended sessions may incur additional fees if the additional time is not paid by an insurer.

**Therapy Services Offered for Adults 21 and Over and Seniors, Age 65+:** Individual, family and group therapy and EMDR\* to address anxiety and mood disorders, posttraumatic stress disorder, life transitions, relationship issues, bereavement, and spiritual or religious problems. Dr. Seeman does not provide therapy with children but can refer to other providers who perform that service. \*EMDR = Eye Movement Desensitization and Reprocessing, an evidence-based trauma therapy.

**Psychologist Licensure:** Psychologists practicing for a fee must be licensed with the Department of Licensing for the protection of the public health and safety. Licensure ensures that the psychologist has a doctoral degree from an accredited graduate school and has passed written exams given by the Washington State Examining Board of Psychology.
